The Queensland Masters Bulls will be returning in 2017. There will be a Twenty20 Exhibition match on Saturday afternoon at York Street.

DATES FOR 2017 – NO PUBLIC HOLIDAY

The 2017 Goldfield Ashes will be held on Friday 20th January, Saturday 21st January and Sunday 22nd January.

Please ensure your travel arrangements are made with regards to these dates. The Committee attempts to meet all requests for morning or afternoon games however there is no guarantee that this will occur.

A GRADE – 2017 – Nomination Fee \$660 (including GST)

- Competition will be a 20Twenty competition
- Teams will be required to play 2 games on Friday & Sunday and 1 game on Saturday
- All games played on turf wickets (weather permitting)
- Players to include in playing kits – cricket spikes
- Prize money & trophies awarded in this division

B1 GRADE – 2017 – Nomination Fee \$660 (including GST)

- All games will be 50 over games.
- Game on Saturday will have an earlier start time to allow game to be completed before Qld Masters Bulls Game at York Street.
- Committee reserves the right to reduce from 50 overs to 35 overs if grounds become unavailable due to excessive water on playing fields.
- Teams are advised that should the committee need to adjust the playing fields due to unavailability it will be done in order of grade commencing with B1, then “A” grade if necessary.
- Trophies awarded in this division.

B2 GRADE – 2017 – Nomination Fee \$550 (including GST)

- Not a competitive grade
- Games are 35 overs per side on Friday & Sunday.
- Games on Saturday will be 20 over games to allow all games to be completed before Qld Masters Bulls Game at York Street.
- Committee reserves the right to upgrade/downgrade teams in all grades if they believe it is in the best interest of the carnival
- Trophies awarded in this division.

SOCIAL GRADE – 2017 – Nomination Fee \$550 (including GST)

- Not a competitive grade
- Games are 35 overs per side on Friday & Sunday.
- Games on Saturday will be 20 over games to allow all games to be completed before Qld Masters Bulls Game at York Street.
- Committee reserves the right to upgrade/downgrade teams in all grades if they believe it is in the best interest of the carnival.
- Trophies awarded in this division.

LADIES GRADE – 2017 – Nomination Fee \$550 (including GST)

- Dependent of availability of fields.
- Minimum of four sides required for competition to proceed.
- Games are 35 overs a side on Friday & Sunday
- Games on Saturday will be 20 over games to allow all games to be completed before Qld Masters Bulls Game at York Street.
- Ladies teams are reminded that they must fulfil all conditions which includes the provision of cricket equipment and umpires for each game.
- Trophies awarded in this division.

CRICKET EQUIPMENT

As mentioned previously, the nomination fee will again cover the provision of two new balls for each day's play in all Grades. This ensures consistency in the type of ball used in each Grade. Teams are reminded however that this is the only cricket equipment provided by the Committee. It is therefore imperative that your playing equipment list not only includes a regulation cricket set, but also:

- A set of stumps
- A strong straw broom
- A large tarp and/or an appropriate shade cover
- Spare balls
- Canvas cricket mats in the appropriate grades (A and B1)
- A set of boundary markers

** "A" grade teams are still required to have mats at their disposal should weather intervene and games be transferred to concrete wickets.*

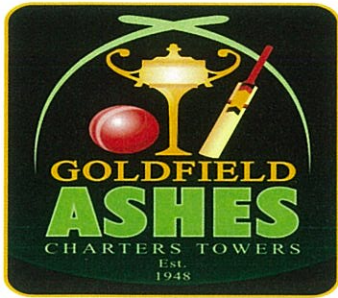
